NOTICE OF PUBLIC MEETING

The Cleveland City Planning Commission will hold a public meeting at **9:00 am on Friday, May 18, 2018** in Room 514, Cleveland City Hall, 601 Lakeside Avenue, to consider the proposed **Rezoning Legislation** listed below:

Ordinance No. TBA: Changing the Use, Area, and Height Districts of parcels of land on West 44th Street between Whitman Avenue and John Court and adding zero foot and eight foot mapped setbacks. (Map Change No. 2583)

All interested property owners or their representatives and neighbors affected by the proposed zoning change are urged to be present to express their opinions on the proposed change in zoning so that the Planning Commission may have the benefit of their testimony in determining the recommendation to be made to City Council. Please note that individual statements made at the meeting will be limited to three minutes.

A second opportunity for comment will be provided at an official public hearing to be scheduled before City Council's Planning Committee. The time of that meeting will be announced through a separate mailing.

Explanation of Proposed Rezoning

Ordinance No. TBA: Changing the Use, Area, and Height Districts of parcels of land on West 44th Street between Whitman Avenue and John Court and adding zero foot and eight foot mapped setbacks. (Map Change No. 2583)

Permitted Uses in Proposed and Existing Zoning Districts:

Existing

Two-Family Residential District: One family houses, two family houses, playgrounds, churches, libraries, hospitals, etc. (Section 337.03).

Area District

Area District 'B' allows for a maximum gross floor area of residential buildings to be equal to ½ the total lot area.

Height District

Height District '1' allows for a maximum height of the building to be 35 feet tall.

Proposed

Residential Attached Townhouse (RA) Districts: low-rise developments of attached single family to two family residential units at medium to high densities. Such developments are intended to serve as a transition between areas of detached residences and areas of higher intensity development or to serve as a means of clustering housing units on sites which can be developed most appropriately through such clustering.

Area District

Area District 'D' allows for a maximum gross floor area of residential buildings to be equal to the total lot area.

Height District


Height District '1' allows for a maximum height of the building to be 60 feet tall.

NOTE: If this proposed zoning change becomes effective, the law requires that the legal use of all existing buildings in the area be allowed to remain, but there can be no additions or expansions of those uses made nonconforming by this change without a special permit from the Board of Zoning Appeals.
